- 2. Dangerous and poisonous Animal Handling Training Course that is accredited in Western Australia This must include the safe handling of snakes, scorpions, ticks, fleas, wild pigs, (can you lot please add to this)
- 3. A two day driving Course accredited in Western Australia that includes the safe driving on gravel, sand and limestone roads
- 4. Heavy Machinery handling course that must include tractors, trucks, bobcats, (please add)
- 5. An accredited course in off grid power solar power systems and the safe use of said system, including domestic/shed wiring
- 6. A DAFF Biosecurity course and this must include the following; Hitch hiker pests, weed biosecurity, horticulture, weeds, plants, locusts, bees, mice, aquatic animals and plants, wild animals, livestock and domestic animals
